Why Are We Here?

- Streets
 - Aged and show signs of distress
 - Rural road section no curb and gutter
- Utilities
 - Minimal storm sewer
 - Aged water main
- Proposed Improvements
 - Full street reconstruction
 - Addition of curb and gutter
 - Storm sewer improvements
 - Replacement of water main and services





 - 17th Avenue





















 - Weston Lane







Assessment Policy

- Assesses adjacent, benefiting properties
 - 40% of street and storm sewer improvements
 - City pays remaining 60%
- Costs not assessed and fully paid by City
 - Water main
 - Sanitary sewer
- Amount of proposed assessment will be provided prior to Public Hearing
- Multiple payment options

Next Steps

- Preparation of bidding documents
 - Incorporate feedback
 - Final construction plans and specifications
- Council approval of bidding documents
 - Not official approval of project
- Solicit bids
- Obtain right of entries
- Public hearing
 - Meeting where decision is made on project
