

## PLYMOUTH OPEN BURN PERMIT

1. The location of the burning shall not be within six hundred (600) feet of an occupied residence other than those located on the property on which the burning is conducted. Also, the location shall not be within fifty (50) feet of a structure or other combustible material on the property on which the burning is conducted.
2. The prevailing wind at the time of the burning shall be away from nearby residences and must be less than fifteen (15) miles per hour. Not to conduct any burning during a RED FLAG warning or alert.
3. The burning shall be conducted as far away as practical from any highway or public road and controlled so that a traffic hazard is not created.
4. Availability at the burn site of appropriate communication and fire suppression equipment as required by the permit.
5. No burning of tree stumps are allowed.
6. Permits are required year-round. **The maximum length of a permit is one (1) week.**
7. Burning is only allowed Monday through Friday between sunrise and sunset on the permitted days allowed for the burn. All fires must be completely extinguished by sunset.
8. **The morning of the proposed burn, the permit holder shall notify the battalion chief on duty (phone 763-337-2732) of the proposed burn.** Calls must be made between 7:00 – 8:00 AM, even if the burning will not occur until later that day. Give an approximate time of when the burn will begin, your permit number and a contact name and phone number on site. If you don't call before 8:00AM you may not be allowed to burn.
9. This permit will not be approved if an alternative method of disposal of the material exists.
10. This permit is subject to revocation at the discretion of a DNR Forest Officer or the local fire authority if:
  - ❖ A fire hazard exists or develops during the course of the burning, or
  - ❖ Any of the conditions of the permit are violated during the course of the burning.

### I AGREE:

- To keep this fire under control and to assume responsibility for all damages and costs that may result from burning done under this permit.
- To attend this fire until completely extinguished. Fire must be extinguished by sunset.
- Not to burn if there is a practical alternative method for disposal of the material such as chipping or composting.
- To use a clean burning device to start the fire.
- Not to conduct any burning during any air quality or RED FLAG warning or alert.
- Not to burn paper or cardboard except as provided under Minnesota Statutes 17.135. To extinguish the fire immediately if this permit is revoked.
- To have this permit available at the burn site for inspection.
- To not allow the fire to smolder.

*This permit is valid for open burning as allowed and specified in Minn. Rules pts. 7005.0705 to 7005.0805 MS 88.16, Minn. Uniform Fire Code and to all ordinances. The permittee is granted permission to burn the above described material at the specified location during the dates and times listed above. I attest, by my signature, that I have read and will comply with the conditions of, and any attachments to, this permit; and that I am the landowner or have permission of the landowner to burn at the above burn site location*
